The demand for repack workers is increasing as we launch two packing lines at a secondary site in the Monroeville Convention Center. *Sent to Feeding Task Force.

Shortages in pantry items (cereal, pasta, pancake mix, canned vegetables), meats (canned and frozen), and dairy (cheese and yogurt). Crawford					The Center for Family Services has seen an increase in individuals needing assistance and food. They continue to operate all of their food pantries with a few provisions and provide access to all basic essential services. They are currently seeing a rapid depletion of their emergency food supply, but some donations have been coming in. No other critical issues related to food or feeding programs.
